ACTION REPORT - Windsor, Missouri

July 23-24 found the troops of the 4th Battalion forming upon the plains on the outskirts of the hamlet of Windsor in south central Missouri. Our goal in this endeavor was to recruit additional men to our cause from the freedom loving citizens of Henry, Benton, Johnson and Pettis Counties. Because of detached duty with the Union Home Guard of Col. John Beck and the men of the 3rd & 6th Missouri Infantry on Saturday, command of the remaining loyal troops fell upon our own Major Robert Koffman, ESQ.

During the recruiting activities, we were surprised by Union troops of the Holmes Brigade under the command of Capt. Strother and the Home Guard Unionists commanded by a short, rotund, vulgar unidentified Col. It was noted that many of his unit commanders must be named "God--," as the command frequently over heard by our scouts, in a deep "frog-like" voice was: "Move that company over there, God----." Major Koffman ably rallied the remnants of our Battalion and, after spirited combat, drove the Lincolnite hirelings from our sacred Missouri soil. The men of the "Fighting Fifth" performed with their usual élan until felled, almost enmasse, by a canister round from a Federal artillery piece.

Sunday found a reversal with Major Koffman, the 5th and the C.S. Battalion from Saturday now serving our required time in the Home Guard. Our troops again performed admirably, despite the blue wool and assisted the Holmes Brigade in driving Col. Beck and the secesh rabble from the field, capturing their camps and their

Col. Following this action, our men united with the elements of several other 4th Battalion companies under my command to provide a filmmaker from the Discovery Channel with close-up footage of Missouri State Guard firing action. This is expected to be available for public perusal in February in a "How the West Was Lost" series episode.

My sincere thanks to Sandra Wayne for arranging this and the other excellent publicity during the entire event. Commendations are hereby provided to the sponsors of the event and specifically, Keith Daleen and the remain-

ing men of the Fifth who worked so diligently to make Windsor a successful event. Com-

ments heard throughout the weekend confirmed that many, both Blue and Gray, considered this one of the better small events staged recently. Once again, another job

well done!

Special mention should be made of the short service both Saturday evening and again at Battalion formation Sunday morning in honor of the late Lt. Col. Dave Okerstrom. Davy was a respected friend to many in the hobby and will be missed around future campfires. A black streamer with Lt. Col. stars was added to the 4th Battalion colors in Davy's honor.

Let's remember him each time we see our colors upon the field.

WINDSOR ACTION REPORT

Sir: It is my honor to report a successful action on the outskirts of Windsor, Missouri on July 23 & 24th.

After much advance preparation by volunteers of Company A, our regiment rendezvoused with other units of the 4th Battalion to meet a Federal force rumored to number nearly 130 muskets. The threat did not materialize, although the Lincolnite hirelings' numbers were bolstered when nearly half our own force switched allegiance -- including our own heretofore beloved Colonel John Beck!!

Thus ably lead by Major Robert Koffman -- with this his first command, our own 5th Missouri, in the van -- the remnants of the gallant 4th Battalion took the field under the hot July sun. Following an artillery duel and cavalry skirmish, we deployed in line of battle to meet the federals, who were advancing in skirmish order.

As the Fifth Missouri held the right -- extending and refusing our line to meet a flank attach by the Holmes Brigade -- the left wing of the Battalion repulsed repeated charges made by the "galvanized" yanks. After much loss of life on both sides, we succeeded in driving the blue scourge from the field, and capturing "Abe Lincoln's Whore" -- John Beck!

The following day we found ourselves impressed into Federal service. Personal honor demanded that we acquit ourselves ably on the field -- even tho wearing blue -- and this we did. I am proud to report that we captured several pieces of artillery and the Confederate commander in a spirited bayonet charge. (All were promptly returned to their rightful owners immediately following the action, as we quickly returned to Southern service.)

Let it be noted that Major Robert Koffman has achieved 2 victories without a single loss when confronting Colonel John Beck.

COLUMBIA EVENT REPORT

Last year's large crowd was missing -- drawn away apparently by the balloon races. Missing too, were the Federals. Yet the Columbia event of August 20-21 proved to be enjoyable nonetheless.

Blessed by spectacular weather, we encamped alongside Company K of the 2nd Missouri amidst a shady grove of trees. We were fed well, and amenities -- after a couple of wood runs -- were generally plentiful. (1SGT Faught welcomed he opportunities to haul wood and gear in his shiny new war wagon).

The first day's action commenced with some close-- order drill for the benefit of the local townsfolk. When both companies had moved out of earshot, a Federal captain by the name of Yoakum attempted to convince the crowd of the "righteousness' of his cause. His exhortations were met with boos and catcalls by the local citizenry. We returned to the field and subsequently drove his handfull of Lincolnite hirelings from the property.

On Sunday the odds had been tipped against us, as Captain Yoakum had been reenforced by Norm Rolfing's artillery piece. Said piece played havoc and destruction



on the ranks of our brothers from the 2nd MO,, and we were compelled to retire from the field. Although Lt. Lee's first combat command ended in defeat, it must be noted that a majority of the Company survived the action. (There is no truth to the rumor that the First Sergeant exited the field in an overly-hasty manner.)

Some distresing news. Privates "Cheerful" Plowman and "Buttons" Pani had to be shot for dereliction of duty. The circumstances of their absence from assigned details are quite embarrassing, and unfit for publication here.

By the President of the Confederate States

A PROCLAMATION

Whereas, an act of the Congress of the Confederate States of America, approved this, the 28th day of November, 1861, provides that, "the State of Missouri be, and is hereby admitted, as a member of the Confederate States of America, upon an equal footing with the other States of the Confederacy, under the Constitution for the Provisional Government of the same:"

Now, therefore, I, Jefferson Davis, President of the Confederate States of America, do issue this, my proclamation, making known to all whom it may concern that the admission of the said State of Missouri into the Confederacy is complete, and that the laws of the Confederacy are extended over said State as fully and completely as over the other states composing the same.

In testimony hereof, I have hereunto signed my name and caused the seal of the Confederate States to be affixed, at Richmond, this 28th day of November, A.D. 1861.

Historical Tidbits Things That Makes You Go Humm

- Two southern states incorporated the rebel battleflag into their state flags: Mississippi in 1895 and Georgia in 1956.
 - 500 Confederate flags were returned to Southern states following the war. However they were not returned by

the federal government until 60 years had elapsed. The reason given was that Union Army veterans objected to any return of the Confederate banners.

- 69% of Americans see the Confederate flag as a symbol of Southern pride.
- 22% of Americans see the flag as a symbol of racism.
- 31% of Blacks surveyed find the flag offensive and 68% do not find it offensive.



A TRUE ACCOUNT OF AN ORIGINAL MEMBER OF THE FIFTH MISSOURI INFANTRY CSA

(The following is the first in a series of diary entries from the Memoir of William A. Ruyle, a soldier of the Fifth Missouri Infantry and the Tenth Missouri Cavalry CSA. A copy of the diary's text was obtained from the U.S. Army Military History Institute.)

If I should fall on the battlefield or die in any other way while this war lasts, I hope some friend will finish my letter by giving a detail of my last days, the manner of death, burial etc. This I desire some friend to do for the satisfaction of my father and family.

Yours, William A. Ruyle Co. C, 5th MO Infty 1st Brig. 2nd Division

What follows is a short sketch of my life and travels, also an outline of the camps and battle skirmishes that I have been in since I joined the Confederate service, January 11th, 1862.

Dear Father

I seat myself with pen in hand to give you a short sketch of my life since I espoused the cause in common with the Southern people. This question, dear father, I think I thoroughly investigated before I took the position I have taken. In investigating this I found myself to be a southern man of the deepest dyes ever, I am opposed to Jayhawking, stealing negroes and other property, or gagging free whitemen, or insulting helpless women and children, which the enemy was heaping upon us even in our midst. Therefore I felt it a duty I owed to my God, my Country and family, to take up my gun in the ranks in common with my fellow soldiers and go forward and fight against these insults and oppressions being heaped upon us by the black Republicans of the North.

On the 11th day of January 1862 at a meeting of the Friends of the South at Pleasant Prairies Chapel, Polk County Missouri, called for the purpose of recruiting for General Price's Army, then at Springfield, MO., after eating the sweet danties which the southern ladies of the neighborhood had prepared and brought in for the soldiers who fight for their right, several speeches were made. After which A. C. Bradford proposed to raise a Cavalry Co., to act as a bodyguard for General Price. About thirty brave boys responded to the call. I was one among them who arose before the stand and was sworn into the Confederate Service in the presence of a large number of ladies and men both old and young. After this we called into line and elected A. C. Bradford, Captain of the squad, who reported us to Gen. Price for duty.



THE SIEGE OF BLAKELEY

YOU MUST CONTACT 1SGT FOR YOUR COMPANY BYSEPTEMBER 1 CONFEDERATE FORCES WILL BE LIMITED

Purpose: To provide the general public an accurate depiction of the siege and assault of Blakeley on April 8-9, 1865, while recognizing the site as a historic and enchanting place very well worth the utmost preservation efforts. To provide the reenactor an enjoyable and historical location to practice his interest.

Pre-registration is required by March 15, 1995. It is a must! Upon invitation and arrival on-site please register. Those participating without registering are TRES-PASSING. If you arrive after registration closes (noon Saturday) you must report to the CS or US commander in order to register.

This event is sponsored by Historic Blakeley State Park and is organized and hosted by Stanford's Battery, Inc.

A maximum of 250 Confederate troops will be allowed to preregister and those over 150 miles away will be given priority. Please understand the intent with this: Confederates at Blakeley were outnumbered 5 to 1. Most all field improvements during the upcoming year will focus on the Federal works and camp site.

All participants under 17 years of age are required to have a responsible adult co-sign their registration.

General Scenario and Situation: Historic Blakeley Park is remotely located with no electricity, running water, or improved roads and the battlefield is isolated from the main Park. Vehicle parking will be very limited so please consider carpooling and arriving early. The scenario begins Saturday morning with a field "tactical" that will involve infantry and cavalry portraying the maneuvers that drove the Confederates into the works. The "tactical" will be held on improved terrain in the park. The siege operation will be in effect immediately afterwards from noon Saturday until 2 p.m. Sunday when the Federal assault occurs. During the siege, all soldiers are expected to "play the part" within the siege boundaries, i.e. stay behind trenches, sharpshoot, participate in sorties, man rifle pits, prepare rations in camp, perform camp chores, etc. while the public moves about and observes. The concept is that of a very large living history program. The public will enter the site at

By now everyone should know it's also standard practice to bring along your federal sack coat & kersey blues to EVERY event, in case we are called upon to galvanize.


