# BULLETIN! URGENT NEWS FROM THE FRONT! THUNDER OF WAR IN THE OZARKS!

#### EVENT REPORT: FT. BLAKELEY, ALABAMA

A disappointingly small turnout of registered members (less than half) answered the long roll April 8th & 9th to do honor to the men we purport to represent. Those who participated experienced a little of the good, the bad, and the ugly during this first event of the new campaign season.

First the good. Not often in this hobby will you enjoy the opportunity to recreate events involving our adopted unit on the very same spot and on the precise anniversary of those events.

Upon first look at the preserved remains of Redoubt #4, it's easy to see why one officer in the 1st-3rd Cavalry (dismounted) called it "the best works we ever fought behind." We were able to camp in and behind these impressive fortifications, and were assigned to defend a stretch of trench within yards of where the 3rd-5th was stationed 130 years ago. The weather was delightful, and the crowds large and eager to learn about the true role of Missourians during the conflict. Other highlights for this writer were the "almost like being there" experiences associated with the Saturday morning tactical. It proved to be an eye-opening experience for those not familiar with the command ability of Col. W.G. Rambo, who's battalion galvanized as federals and whipped Col. Beck at every turn.

Now the bad. It was somewhat of a disappointment to have only ten military and one civilian attend this rare event—especially in light of the fact that more than twice that many committed to go. As a result of the unexpected shortfall in numbers (only three notified the 1st SGT, they could not make it) we often found ourselves so understrength that all we could do was hold the trenches while the battalion sortied. Even with the addition of 4 men from the 32nd Alabama we were the smallest company on the field. For the grand assault on Sunday afternoon, we counted one officer and six men among us. We were also somewhat dismayed to see the published campaign-style camping requirement universally ignored.

Finally, the ugly. We have seen an alarming increase in unsafe behavior in the field over the past year. In the past we've often placed the blame on others. After this event we must look at ourselves. Both the MCWRA and our unit have maximum load restrictions for revolvers. Elephant loads serve no purpose but to gratify the ego of the person discharging his "hand cannon", and at Blakeley may have contributed to the escalation of an incident that might otherwise have been overlooked. The fixing of bayonets, the use of other edged weapons, and the ramming of charges during opposing fire are other acts universally considered to be unsafe except in specific, controlled circumstances. We must see to it that those who know better — and those who don't — do not besmirch the good name of this company by violating published safety standards. Before participating in the field this year, all will be required to sign a statement attesting to their familiarity with 5th Missouri and MCWRA safety guidelines.

### THE TRUE ACCOUNT OF AN ORIGINAL MEMBER OF THE FIFTH

From the Diary of William Ruyle

The Battle of Corinth (Oct. 3rd) cont......

At last General Green was reinforced and drove the enemy back. It was here Gen. Green's Brigade suffered their greatest loss, they were in an open field with a shower of . . . . . . shell, cannister and musketry all the time. In the meanwhile we were lying on their left in an open field and it seemed that all the balls just passed over us. The weed's were about four feet high and when I would look up I could see the bullets cutting the tops of the weeds over us constantly. This time I think I got closer to the ground than I ever did before and I think the others can say the same. If we had been 10 feet forward on the top of the hill I don't think any of us would have escaped. Some of the Companies, in the Regiment who were higher up, suffered greatly. We were again ordered forward to the Mobile and Ohio railroad. Here we lay on our arms all night, without blankets and coats and almost without rations, occasionally shooting at the Feds and getting water out of the mud holes on the otherside of the railroad. This was the only water we had to drink, just then.



About an hour before day the Feds opened their batteries upon us, some were large pieces, and the continued roar of cannonading was kept up until the charge was made about 9:00. The Feds had a line of skirmishers in our front in a good position, who would shoot our men whenever they would poke their heads above the railroad. In this way they killed and wounded some of our best Officers and soldiers who were anxious to get a shot at them. Samuel Lane, a Sgt. of our company was hit, by a spent ball, in the forehead but the wound proved to be slight and he was well soon.

At about 9:00 we were ordered to charge their inside fortifications near Corinth about a quarter mile from the railroad. This we promptly did, driving back a strong line between us and the breastwork, yelling and hollering. We charged their breastwork and drove them admist a shower of Cannon balls, and musketry which was poured upon us from the front, right and left. This was because our forces on the right and left didn't come up promptly on time. We remained in their breastworks, fighting to hold our position and receiving the crossfire of the Feds for more than a half hour.

We had possession of a large number of cannons which they had deserted. This was one of the bloodiest places I ever saw. On all sides of me I could see both the enemy and our own men lying killed and wounded, shot in almost every way you could think of, groaning and dying in the bleaching sun in the dust which was about six inches deep. Every second it seemed I could see some comrade fall dead or wounded.

At last giving up all hope of getting reinforcements, meantime the enemy had received reinforcements and had rallied again, we were bound to fall back and give up all we had gained, this we did in considerable disorder in spite of our officers. This was Oct. 4th, 1862. The battle of Corinth, Mississippi was one of the bloodiest affairs of the war.



#### **DETAILS OF UPCOMING EVENTS**

PEA RIDGE: 5TH MO MAX EFFORT. (5/5-7) We registered a total of 35 Military & 11 Civilians. Some have yet to pay the \$5 fee. ( See the commitment list in the last issue). The Site is four miles northeast of Pea Ridge National Military Park. Two possible routes are by U.S. 71 South to Bentonville/ Rogers then east on U.S. 62 or MO 37 South from Monett then west on U.S. 62. There will be both tented and campaign-style camping. Bring your "A" tent if you'd like. We'll set up a fixed camp and then follow the Battalion's lead once the event begins. At this point we're still assuming we'll have to galvanize for one scenario. Otherwise, your required impression is Missouri State Guard. Those who wish will be able to march 4 miles to the Park, camp on the actual battlefield Friday night, then march back to the site for Saturday's battle. There are three battle scenarios scheduled: Cross Timbers Friday at 5pm, Leetown Saturday at Noon, and Elkhorn Sunday at Noon. There is also a full slate of civilian activities. including a seminar on life in the civilian camp Saturday morning, a tea with a talk on fabrics & another talk on etiquette Saturday evening, and a barn dance Saturday night. Northwest Arkansas is literally CRAWLING with ticks, so dowse yourself liberally with a DEET-containing repellant.

MAYSVILLE: (5/27-28) This will be a fun little event to commemorate DeKalb County Sesquicentennial. Activities include a secession rally, parade, skirmishes, and possibly a tactical in a wooded area. Response from yanks has been characteristically light, so bring the Blue Suit. Sponsored by the 3rd MO. They are hoping for support from the 5th, 6th & 2nd MO. Maysville is on MO 33, northwest of Cameron. Site is west and south of town. Watch for signs. Get commitments to 1st Sgt. NOW.

COLUMBIA: (6/10-11) This is our annual Living History at the Maplewood Mansion in Nifong Park. It's located on U.S. 63 just south of town, adjacent to the Boone County Historical Society museum. Take the AC exit. Parks & Rec plans on a skirmish each


day, a period church service, and entertainment Saturday evening. Food for 4 meals is provided. The 1st Sgt. will register you through the company, if you'll get your commitment to him PRIOR TO JUNE 1ST.

THE LAST SURRENDER (Watie's Retreat): (6/23-25) Anyone serious about experiencing a real campaign-style event should contact the 1st Sergeant as soon as possible for a registration form/release. There is a \$25 fee to offset the costs of this unique event, which will include two days of marching/fighting 6 miles each day, and a third day of 2 1/2 miles. A 12-mile train ride back to the surrender ceremony on Sunday will conclude the event. Authentic rations provided (3 days marching rations issued on Friday morning).

COLE YOUNGER DAYS: (6/23-25) (Optional — new addition to schedule on same date as Watie's Retreat) A Guerrilla affair at the Lees Summit ATT Building. Includes Saturday morning parade. Jerry & Cindy Lee have details — overview at Spring Drill.

JEFFERSON CITY CEMETERY WALK: (7/2) Second annual event at Woodland and Old City Cemetery beginning at 1pm. Living history and recruiting booth. Contact Sgt. Faught if you can participate.

FULTON: 5TH MO MAX EFFORT. (7/15-16) Preregistration must be in by JUNE 1. Site is a 71 acre wooded area 7 miles east of Fulton, near Calwood, Mo. Saturday's scenario is a "what if' battle between Confederate and Federal forces based on the "Kingdom of Callaway" treaty legend. Sunday's action is the Battle of Moore's Mill. Uniform guidelines are regular Confederate for Saturday and Civilian or Guerrilla for Sunday. Be prepared to galvanize. Complete schedule and details in June Messenger. Sponsored by the 6th Missouri.



#### **Profiles of Our Commanders**

#### General Earl Van Dorn (1820 - 1863)

Earl Van Dorn was one of the Confederacy's most promising general officers early in the Civil War. A native of Mississippi and a West Point graduate he had all of the likely skills to become one of the South's finest, but his interests in another man's wife spelled his doom, dying at the hands of a jealous husband. Following his graduation from West Point, he was posted to the infantry where he won two brevets in the Mexican War for bravery, wounded in the assaults on Mexico City. Transferring to the cavalry in 1855, he was wounded fighting Indians near Wichita Village, Indian Territory.

Resigning his commission from the second cavalry on January 31, 1861, he offered his sword to his home state of Mississippi. He was made a Brigadier General on the same day he left the old army. Perhaps few other generals served in a greater variety of regional postings as did Van Dorn. In 1861 alone he served in Mississippi, the Department of Texas, and the Potomic District - Army of Northern Virginia. His last command was over a division of the Army of Tennessee (February 25 - May 7, 1863).

Early in the war while he commanded in Texas, he seized U.S. property and received the surrender of regular army forces. Following this he was promoted to brigadier and major general CSA and was ordered east to command a division near Manassas, Virginia. Early in 1862 he was ordered back west to command in Arkansas in order to smooth things out between Price and McCulloch. This cooperation was crucial in launching an attack against the Union forces at Pea Ridge/Elk Horn Tavern. The confederate forces were repulsed after two days of fighting.

Ordered east of the Mississippi, he arrived to late to take part in Shiloh, but he participated in the unsuccessful defense of Corinth, Mississippi. In the summer of 1862 he successfully defended Vicksburg but failed in his designs on Baton Rouge when the attack failed under John C. Breckinridge failed. Another failure occurred when he attempted to retake Corinth in October 1862. By this time many Southerners were disenchanted with General Van Dorn, but he was still seen as an important military leader and therefore he was given command of the mounted troops under Pemberton.

His raid on Holly Springs, Mississippi, was a major factor in ending Grant's campaign in central Mississippi. Moving his division into middle Tennessee, he was killed on May 7, 1863, by Dr. George B. Peters for attentions paid by the general upon the physician's wife in Spring Hill.


