# Bragg lays siege to Chattanooga

#### **EVENT REPORT**By DENNIS FAUGHT

On Nov. 5, 1863, the 5th Texas Infantry Regiment was pulled from the chain of sentinels along Lookout Creek, at the base of Lookout Mountain, Tenn. Replacing them were men of the 27th Mississippi. Across the creek was the 60th New York, part of the relief column that had recently broken the siege of Chattanocga via the Cracker Line.

"While here the two picket lines at many places were not more than 40 yards apart," wrote Private Robert A. Jarman of Company K, 27th Mississippi. "We could see and hear them relieving their pickets, and they could see us. We even met halfway in the creek, where it was shallow and shoally, to swap newspapers, canteens and tobacco for coffee. And I have seen some swap hats and shoes, and talk for half and hour at a time. But this was only when no officer was present on either side."

On Nov. 5, 1999, we met on a north Georgia farm to recreate these events. Rifle pits and breastworks had been constructed along a meandering, spring-fed creek. Looming in the distance was a ridge that bore a striking resemblance to Lookout Mountain. Following is my letter home:

Dear family,

I take pen in hand to relay some of what has happened to me since the battle at Chickamauga. On the 5th, the Reg't was assigned a portion of the picket line at the base of Lookout Mtn. at Chattanooga. Justin G. was among an advance party sent to prepare the works for us. I followed with the Capt. and the balance of Co. K the next morning. When we arrived, 3rd section was

detailed to dig sinks. I was in 2nd section, and on firewood detail. It seemed as though I did little but gather wood the rest of the day, but the stocks were welcome as the temperature dropped.

My first hours on picket were uneventful. I and a young new recruit were assigned the left-most rifle pit on our front. The Lieut. said Company I was to our left, but I saw no one there all day. About midday we formed a storming party and rushed across the creek to nab a Yank prisoner. My section provided covering fire from our side of the creek. We lost no one in the fracas, and got our prisoner. (He was later traded back to them for 20 pounds of food).

Later that day a truce was arranged. Turns out these yanks were from New York, but wouldn't say what Reg't. With the officers absent, a good deal of trading took place along the creek, which was just ankle-deep at the ford. Justin was able to procure a good supply of coffee beans in exchange for a burleigh twist. At mail call Justin received a letter from his cousin. I received none, and wonder why you haven't written.

About this time a group of refugee women were escorted across the creek, having come through the yankee lines from Chattanooga with only the clothes on their back and a small cart of belongings. My heart aches for these poor women, and I pray you are not in similar straits yourself in Mississippi.

Our first night on outpost, 2nd section was given the midnight to 6 detail, so we settled around a fire in the works soon after darkness fell, hoping to get some sleep. The Lieut, waked us at midnight,

and placed Justin, Dean B. and I at Post number 11.

The hours passed fitfully, the silence occasionally broken by a shot at some perceived intruder. The night was inky black, with no moon, and nerves were raw. Dean and I passed much of the time swapping rumors about the war and wishing we were back home in Monroe County

Justin shouted across the creek — "Hey Yank, tell us a bedtime story!" To which a voice in the darkness replied, "Once upon a time there was a town called Vicksburg. Then we burned it. The end." We immediately sent a minnie ball his way for the impertenance.

The yanks got into Post number 12 at

one point, trying to take a prisoner, but were repulsed. Twice before dawn their cavalry splashed across the ford and briefly got in our rear. No one was lost, although I'm sure I unhorsed one of them as they passed in front of our post.

Once the sun rose, a most curious thing happened: Dean and Justin were having quite a laugh at two yanks bobbing their heads above the works as if they were turkey gobblers, when, without so much as a "find a hole, Johnny," a bluebelly from another post sent a shot buzzing past our ears. We answered with several more shots, and a few choice words. Then Dean tossed a tater in their direction. It struck just in front of their headlog, causing the offending yank to pop his head up to see what had landed. Justin put a ball in his forehead at 40 yards.

That morning we had designs on making a general assault across the creek. A handfull of us were left in the pits to

decoy the yanks, while the rest of the company formed for the assault on our right. But Dean saw that the yanks were up to something as well. They were relieving their posts, but not dropping off new pickets in them. We sounded the alarm, and about that time they made a dash across the ford, routing post number 12 to our left, flanking our position. I got off one shot, grabbed my knapsack and ran for the Grand Guard trenches, where I found more yanks coming up the hill from that side. Justin and Sergt. Smotherman dropped their empty muskets and tackled a couple of them. dashed for the safety of the trees. But they were all around us by now. I got one more of them from behind a tree before feeling a sharp pain in my hip.

My wound is healing slowly. They are sending us to Point Lookout prison in Maryland, I'm told. Please write me soon as I fear sometimes I will never hear from

you again.
